Mail a dated copy of your sales receipt including the firearm's serial number, a copy of page 3 of your BATFE Form 4473 (or a signed letter from your dealer, on the dealer's letterhead, stating they refuse to release a copy of the Form 4473) and this promotional form for each eligible FN firearm purchased to: Limit one rebate per eligible FN firearm purchase, and one offer per name and address.

(The BATFE Form 4473 or Firearms Transaction Record is a U.S. Government document that must be filled out when a person purchases a firearm from a Federal Firearms License holder.)

This offer is valid only within the United States on the consumer retail purchase of new FN FNS firearms between August 15, 2012 and November 30, 2012. Pre-owned, rental, demonstrator or otherwise used FN FNS firearms are not eligible for this promotion. **Eligible rebate reimbursement is for \$50 on the purchase of a new FN FNS firearm.** All rebate paperwork must be postmarked by midnight December 15, 2012. FNH USA is not responsible for late, lost, mutilated or misdirected mail. All unauthorized duplicates or invalid submissions (including incomplete and illegible submissions) will be automatically eliminated.
